The Contractor shall demolish the complete building including, plinth protection, flooring in and around the building and all other structures including RCCslabs, beams, columns, masonry walls, doors, windows, ventilators and all other items dispose the debris as per rules and regulations of National Green Tribunal(NGT), at their own cost.

Before actually taking up the demolition of the building the Contractor shall ensure proper disconnection of Electrical power to the building and disconnection of water supply and sanitary connection of the building .Contractor shall have to provide all safety appliances i.e. safety helmet, safety belt etc. to his workers while working at height with his own cost and follow all safety rules and regulation and all statutory provisions etc in force.
